## Specific Part

### 1 Technical description of the product

The subject of this approval is the post-installed connection, by anchoring or overlap connection joint, of reinforcing bars (rebars) in existing structures made of normal weight concrete, using the injection mortar Fischer FIS VL in accordance with the regulations for reinforced concrete construction.

Reinforcing bars made of steel with a diameter  $\phi$  from 10 to 25 mm and injection mortar FIS VL are used for rebar connections. The steel element is placed into a drilled hole filled with injection mortar and is anchored via the bond between embedded element, injection mortar and concrete.

The product description is given in Annex A.

### 2 Specification of the intended use in accordance with the applicable European Assessment Document

The performances given in Section 3 are only valid if the rebar connection is used in compliance with the specifications and conditions given in Annex B.

The verifications and assessment methods on which this European Technical Assessment is based lead to the assumption of a working life of the anchor of at least 50 years. The indications given on the working life cannot be interpreted as a guarantee given by the producer, but are to be regarded only as a means for choosing the right products in relation to the expected economically reasonable working life of the works.





Overlap joint with existing reinforcement for rebar connections of slabs and beams





Overlap joint with existing reinforcement at a foundation of a column or wall where the rebars are stressed




**Figure A3:**

End anchoring of slabs of beams (e.g. designed as simply supported)




**Figure A4:**







## Specifications of intended use

### Anchorage subject to:

Static and quasi-static loads

### Base materials:

- Reinforced or unreinforced normal weight concrete according to EN 206:2013  
Strength classes C20/25 to C35/45 according to EN 206:2013
- Maximum chloride concrete of 0,40% (CL 0.40) related to the cement content according to EN 206-1:2013
- Non-carbonated concrete  
Note: In case of a carbonated surface of the existing concrete structure the carbonated layer shall be removed in the area of the post-installed rebar connection with a diameter of  $\phi + 60$  mm prior to the installation of the new rebar  
The depth of concrete to be removed shall correspond to at least the minimum concrete cover in accordance with EN 1992-1-1:2004+AC:2010  
The foregoing may be neglected if building components are new and not carbonated and if building components are in dry conditions

### Temperature Range:

- -40°C to +80°C (max. short term temperature +80°C and max long term temperature +50°C)

### Design:

- Anchorages are designed under the responsibility of an engineer experienced in anchorages and concrete work
- Verifiable calculation notes and drawings are prepared taking account of the forces to be transmitted
- Design according to EN 1992-1-1:2004+AC:2010 and Annex B 2 and Annex B3
- The actual position of the reinforcement in the existing structure shall be determined on the basis of the construction documentation and taken into account when designing

### Installation:

- Dry or wet concrete
- It must not be installed in flooded holes
- Overhead installation allowed
- Hole drilling by hammerdrill or compressed air drill mode
- The installation of post-installed rebar shall be done only by suitable trained installer and under Supervision on site; the conditions under which an installer may be considered as suitable trained and the conditions for Supervision on site are up to the Member States in which the installation is done
- Check the position of the existing rebars (if the position of existing rebars is not known, it shall be determined using a rebar detector suitable for this purpose as well as on the basis of the construction documentation and then marked on the building component for the overlap joint)

## 1. Drill hole

Note: Before drilling, remove carbonized concrete; clean contact areas (see Annex B 1)  
In case of aborted drill hole the drill hole shall be filled with mortar.



Drill hole to the required embedment depth using a hammer-drill with carbide drill bit set in rotation hammer mode or a compressed air drill.

## 2.1 Compressed air cleaning

	<p><b>Blowing</b> three times from the back of the hole with oil-free compressed air (min. 6 bar) until return air stream is free of noticeable dust.</p>
	<p><b>Brushing (with power drill)</b> three times with the specified brush size (brush diameter &gt;: borehole diameter) by inserting the round steel brush to the back of the hole in a twisting motion. The brush shall produce natural resistance as it enters the anchor hole. If this is not the case, please use a new brush or a brush with a larger diameter. For appropriate brushes see Table B4.</p>
	<p><b>Blowing (control)</b> three times from the back of the hole with oil-free compressed air (min. 6 bar) until return air stream is free of noticeable dust.</p>




